Minutes of the Parish Council meeting

held on 9th October 2023

[A] Apologies were received from Parish Councillor Howes, Somerset Councillor Wren, Parish Councillor Hill and Somerset Councillor Mansell. Four parishioners were also in attendance

[B] Issues raised by members of the public.

[i] Concern was expressed over the sale of the Holywell Inn, which has seen a number of changes in use and "development" over the years, but its future is very much at the heart of the local community. Planning permission would need to be sought for a change of use, but it may be sold as two separate units. The council was unanimous in its desire to defend local issues and it was agreed to contact Councillor Mansell to look if there have been similar issues in the county, and to help to look at possible sources of funding. However it was still agreed that the best outcome would be its continuation as a public house, with local support. The likelihood of a local petition was discussed, although there was no definite outcome. However canvassing the local population was suggested, and Councillor Frear reiterated the encouragement of local support at this time and in the future should it remain as an inn.

ACTION. Council to contact Councillors Mansell and Wren to investigate the "four year rule" and other local public houses

[ii] Mr Payne raised the issue of the installation of a self-closing gate on a footpath at Thorne St Margaret, which has been opposed by the local landowner on whose property the footpath lies

ACTION: Clerk to ascertain local situation

[iii] Mr Payne raised the issue of the speeding in Holywell Lake and the installation of a suitable speed recording device. The clerk, as Speedwatch coordinator in Ford Street, mentioned the extreme figures in that area, which are the highest in Somerset, and the possible installation of a Speed recording device. The latter issue seems to have been put in abeyance by those in authority. Councillor Howes still awaits a response from traffic engineer Kate Brown from Somerset Highways regarding the next steps towards the introduction of a 20mph speed limit.

ACTION: Clerk to pursue the SID installation and investigate other local support as above ACTION: Await response from Kate Brown

[iv] It was agreed that the installation of a 50mph speed limit on the southern A38 from close to Wellington to near junction 27 of the M5 was to be welcomed. This may not occur until the spring of 2024, and may necessitate additional work such as tree trimming. The safety of the Holywell Lake/Beambridge junction was questioned and it was considered by a parishioner that it may be worth pursuing the construction of a traffic island. This may be returned to at a later meeting,

[e] Ridge Farm planning application 44/23/0014. The chair will ascertain any local concerns and contact the clerk should it be necessary.
